# CORONAVIRUS CONTRACTOR SURVEY 4: STABILITY & ANXIETY OCTOBER 5, 2020





## Survey Highlights & Methodology

#### Top Contractor Concerns

- A second wave of Covid-19 is still the biggest concern of contractors
- There has been little change over concerns with other top concerns since previous surveys. These concerns include: supply chain disruptions, skilled labour availability, and ensuring health and safety of workers and staff
- There has been a significant decline in concern regarding project cost over-runs due to sanitation, safety and social distancing protocols

#### Status of Construction Activity

- Contractors report that on average, 23% of their work is stopped because of the coronavirus, down from 28% in Survey 3
- They also report that 29% of work is delayed on average, down from 41% in Survey 3
- 56% of contractors say most or all of their work has now resumed, up from 49% in Survey 3

#### Other Disruptions


- Supply chain disruptions have not improved since the pandemic began, with 64% reporting high or medium impacts
- 52% of contractors report that building permit processing has been slower than usual this summer (since July 1)
- 46% had more difficulty getting skilled labour this summer (since July 1) compared to last

## Forecasting Remainder of 2020

- 51% of contractors expect to do less work in the Sept-Dec period compared to last year, 19% expect more work
- 37% expect it will be more difficult to get skilled labour compared to Sept-Dec last year, while 10% expect it to be less difficult





#### How individual construction firms report being impacted by the coronavirus





## **Bidding Trends**



## Impact of Coronavirus on Project Costs



Contractors were asked to estimate how much their overall project costs have increased as a result of implementing PPE and physical distancing requirements on construction sites. In previous surveys, contractors were asked to project what the increases would be. In Survey 2 the average estimate was +23%, and in Survey 3 it was +13%.






Work expectations for September-December compared to September-December 2019

### Contractor Comments on Work Expectations for the Remainder of 2020

"With the opening of the economy more projects are coming forward, but owners are hesitant to make commitments on project start dates. They're moving forward on getting quotes and estimates, but non-committal on start dates." "Municipalities are not giving permits. Not issuing permits is our biggest problem."

"2021 has us concerned. I don't think people have put out all the jobs they have, because no one knows what the second wave is going to be like."

"Not worried about 2020. I'm worried about 2021 and 2022." "Work now depends on government stimulus. If they're not giving any, then everything could be slowing down. If government does not get involved or if they take too long, we will really feel this. I know a bunch of big companies who are in trouble now. It may be too late to get out of the trouble."

"We were anticipating more work to start but because of Covid-19 it has been defered to 2021."

"Work will be extremely slow and money extremely tight."

"We feel a lot of anxiety whether the economy will recover long term. The government has been helpful but we had to take on debt."

"Work is non-existent." "I don't think it's going to change much for 2020. It's 2021 we're concerned about. I think this spending that the government is doing has to come to an end, and that's going to result in much less work being led by municiplaties. If they're going to spend money they should spend it on infrastructure."

"We've always had problems finding skilled help. It'll be worse now."
