Key research deliverables in 2021 included: Institute for Work & Health's Union Safety Effect study; Demographics and Diversity in Ontario's Unionized ICI Construction Industry; Training Investment in Ontario's Construction Industry; and a Project Labour Agreement Guide.

We continue to push ourselves to set higher standards in research, industry promotion and innovation and our team is proud of the work we have done and the partnerships we have grown and developed over the past year. Much of this growth is from your support, our industry partners, who have supported us at our events and with our research initiatives.

We look forward to the year ahead with great hope for a healthier and more equitable future. Please take a moment to review our accomplishments on the pages that follow.

RESEARCH

The Ontario Construction Secretariat continues to fulfill its research mandate by undertaking independent and impartial research on issues of importance to Ontario's unionized construction industry. Over the past year, we have focused on safety, demographics and diversity, investment in training, project labour agreements as well as regular updates on economic indicators, construction activity and labour market conditions.

Our research reports and resources help our stakeholders to better understand current and future market forces in order to make fact-based decisions. The findings of our in-depth research projects are made available to stakeholders for use in discussion with government policy makers, labour-management partnerships and in the promotion of the unionized construction industry. All OCS reports and bulletins are available at www.iciconstruction.com. Here is a brief summary of key research accomplishments from the past year.

Union Safety Effect

IIn January, the OCS and the Institute for Work & Health (IWH) were excited to announce the findings of the union safety effect study. The new report, *Updating a Study of the Union Effect on Safety in the ICI Construction Sector*, found lost-time injury claims are 31 per cent lower on unionized building trade construction jobs than they are in a non-union environment – a jump of eight percentage points over the past six years.

The scientific manuscript is now available online and will be published in the November 2021 Journal of Occupational & Environmental Medicine.

Demographics & Diversity

This report builds on the Census-based analysis completed in 2020 with new data collected from individual union locals and aims to dispel the notion of widespread labour shortages by providing a clearer picture of the source, scale and nature of specific challenges.

The report also dives into the theme of diversity. Underrepresented groups accounted for less than 5% of total active members in 2019. Although diversity numbers remain low in the construction sector, more then half of the union respondents have programs in place to enhance diversity in their trade. This report points out that there is still more work to be done. The development of additional metrics is an important step as the industry continues to work towards increased diversity and inclusion.

Project Agreement Guide

Iln response to renewed interest in Project Labour Agreements, OCS updated and enhanced its *Project Agreement Guide*. This how-to manual provides a step-by-step guide to enacting a project labour agreement under the *Labour Relations Act*. The publication also speaks to the benefits of project labour agreements and provides an up-to-date listing of previous PLAs and industry contacts.

Training Investment in Ontario's Construction Industry

With over 100 training facilities across Ontario, including accredited Training Delivery Agents (TDA) that deliver the formal in-school portion of apprenticeship training and non-TDA facilities delivering skills and health and safety training to union members, Ontario's unionized industry plays an integral role in Ontario's skilled trades training system. The unionized sector's annual contribution to training is estimated at \$146.4 million (2019) an increase of 261% from 2011.

Economic and Construction Industry Trends

OCS provides insight on current economic and construction industry trends. This information is shared via the OCS website, OCS Members' website, Economic Bulletins, special industry reports and our annual State of the Industry and Outlook Conference.

The OCS Research and Marketing Partnership Grant (RMPG) is an annual program to assist labour and management organizations with research and promotional activities to enhance the unionized ICI construction sector. Launched in late 2019, the funding program focuses on: Workforce Development; Market Share Growth and Competitiveness; and Innovation or New Technologies in Construction.

All 2021 applications must be jointly submitted by a labour-management partnership that is affiliated with an Employee/Employer Bargaining Agency by November 30, 2021. Applications must incorporate cash or in-kind contributions.

Over the past three fiscal years OCS has funded four projects totaling \$180,000.

LiUNA Local 1059

Developed an educational virtual reality (VR) experience to raise awareness of ICI construction advantage and present a professional image of careers in the skilled trades. The VR experience provides real-life experiences utilizing video from actual union jobsite showcasing equipment and technology used by workers. This VR tool will be used at job/career fairs, schools, and public events in London and southwestern Ontario.

UA Local 67/ MCAHN

Implemented Research and Development Phase Two and final Phase Three campaign to match the OCS Union Safety Effect. Campaign collateral was updated from 23% to 31% Safer and the funds were used to hire a public relations firm to support the safety messaging efforts including a qualitative analysis, radio ads, email signatures, and an Economic Forecast Media Report.

Waterloo Wellington Dufferin Grey BTC / Golden Horseshoe General Contractors Association

Upgraded marketing materials including the Building Trades Council's website, social media presence and print brochures. The Council and their contractor partners developed a marketing campaign targeting regional area hospitals, post-secondary institutions, schools, municipalities as well as maintenance opportunities at regional manufacturing facilities. The campaign focuses on the unionized sector's track record with respect to on-time, on-budget job completion and exemplary safety record.

IBEW Local 804 / ECA-Central Ontario

A dynamic marketing campaign (TV commercials, radio, and social media) aimed to raise awareness with buyers of construction services in the Kitchener-Waterloo region. The campaign focuses on the link between training and certification and enhanced safety, quality of work and reliability. It also shows that unionized workplaces offer the best environment to be an apprentice and develop a career.

2020 ANNUAL GENERAL MEETING & CONFERENCE

The Ontario Construction Secretariat's 2020 AGM & Conference was held virtually on October 6, 2020. OCS stakeholders came together at the annual event to hear from a stellar lineup of speakers and get up to date on OCS plans and projects.

The AGM & Conference is typically an in-person event, however; due to COVID-19 gathering restrictions at the time, OCS pivoted and provided a two-and-a-half-hour virtual agenda.

In addition to the formal business of the AGM, the conference explored a variety of issues that are critical to Ontario's unionized ICI construction industry. Chief Executive Officer IPSOS Public Affairs, Darrell Bricker, delivered the opening keynote address. He shared some insights and relevant data in an effort to help us understand what we are going through and why, and who we still are despite the disruption of COVID-19. Darrell is more than just a numbers guy. He has over 20 years experience in the public opinion sector and has gathered and analyzed the views and data of Canadians from coast to coast.

Benjamin Tal, CIBC's Deputy Chief Economist, provided insights on the economic climate and possible outcomes as we continue to live with COVID-19. Mr. Tal is responsible for analyzing economic developments and their implications for North American fixed income, equity, foreign exchange, and commodities markets.

OCS Director of Research, Katherine Jacobs, provided an update on work the OCS focused on throughout the year including a series of Coronavirus Contractor Surveys, construction and economic indicators, government announcements, skilled labour shortages, the adoption of new technologies in the construction industry, demographic and diversity, community benefits and the union safety effect. OCS said farewell and thanked Joe Keyes, Construction Labour Relations Association of Ontario, for 15 years of service on the Board of Directors and John Grimshaw, IBEW COO, for nine years on the Board of Directors. Their hard work, commitment and dedication are worth admiration and they both will be greatly missed.

2021 STATE OF THE INDUSTRY & OUTLOOK CONFERENCE

On March 4, 2021, the Ontario Construction Secretariat hosted the 21st Annual State of the Industry and Outlook Conference virtually. This informative and well-attended half-day conference featured industry experts, facilitated valuable professional development, provided insight on the economic climate for the year, and examined what construction health and safety practices could look like in a post-pandemic world.

This year's conference opened with CIBC's Deputy Chief Economist, Benjamin Tal, delivering the economic address. Tal discussed the state of the current economic climate, possible outcomes as we continue to live with COVID-19 and insights on what the financial future holds for 2021. Katherine Jacobs, the Secretariat's Director of Research, delivered her annual presentation highlighting the findings from the 2021 Contractor Survey. In March 2020, when Coronavirus took over our lives, OCS decided to implement a series of surveys to gauge the day-to-day impact of COVID-19 on contractors and the construction industry. Katherine provided the audience with a glimpse of what contractors were thinking at the time based on new data from the Contractor Survey and recapped 2020 construction industry indicators and provided a short-term outlook for the industry.

Enzo Garritano from Infrastructure Health and Safety Association facilitated a panel discussion with Stephen Callender of Bass Installation, Afro Canadian Contractors Association (ACCA), Ron Kelusky Ontario's Chief Prevention Officer, Erin Oliver of Modern Niagara, and Carmine Tiano of Provincial Building & Construction Trades Council of Ontario where they discussed opportunities and challenges associated with health and safety in a post pandemic world.

Delivering the keynote address and wrapping up the event was David Frum, Senior Editor at The Atlantic and New York Times Bestselling author. Frum has been a long-time advocate for shaking up the polarized US political system and he provided fascinating insight into what recent political outcomes meant for specific audiences around the world, bringing Canadian ethics into the forefront.
